Subject : Notification VIII for partially Qualified Candidates for Departmental Examination – 2010 for (i) ITOs & (ii) ITIs

Madam/Sir,

In exercise of the powers vested by Rule III of Amended Departmental Examination Rules for ITOs & ITIs 2009 and with the approval of Chairman CBDT, the age limit specified in the Ist proviso to Rule III for the Partially Qualified Candidates of the Old Pattern has been removed for the Departmental Examination 2010, thereby making the partially qualified candidates of Old Pattern who have exceeded the age limit of 55 years as on 01.04.2010 but have not **exhausted ten chances**, eligible to appear, in the Departmental Examination 2010.

2. In view of the aforesaid, those candidates who thus become eligible may now submit their applications with the jurisdictional CCIT/CIT (Incharge of Examination) immediately. These application forms should be brought in person by the authorised officer coming to collect the papers as per the revised schedule of collection given overleaf. The Roll Number, admit card and attendance sheet for these candidates shall be uploaded on the Departmental website incometaxindia.gov.in and can be downloaded on 25/11/2010. **This may be given wide publicity.**

3. All CCsIT/CsIT (Incharge of Examination) are requested to ensure that all the application forms of the aforesaid candidates are sent to the Directorate through the authorised officer as per the revised schedule indicated overleaf. They also are requested to ensure that the admit cards reach the candidates well in time.
