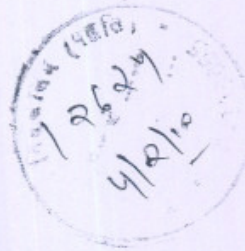

RECRUITMENT OF MERITORIOUS SPORTS PERSONS IN INCOME TAX DEPARTMENT

The Chief Commissioner of Income Tax, Delhi-I, New Delhi, invites applications for the Recruitment of meritorious Sportspersons in different games, sports as listed below for the posts of Inspector in the pay scale of Rs.9300-34800(Grade Pay Rs.4600/-) and Tax Assistants in the pay scale of Rs.5200-20200(Grade Pay Rs.2400/-). The posts are purely temporary but likely to be permanent. The probation period is of 2 years.

ELIGIBILITY CONDITIONS

01. AGE LIMIT :

i) **Inspector :** 18-27 years (as on closing date of receipt of application)

ii) **Tax Assistant :** 20-27 years (as on closing date of receipt of application)

Relaxation : (relaxable upto 5 years for General/OBC candidates and 10 years in case of SC/ST candidates). The age limit is also relaxable for Departmental candidates upto 35 years (relaxable upto 40 years in case of SC/ST departmental candidates).

02. EDUCATIONAL (1) For Inspector :-

QUALIFICATION (i) Degree from the recognized University.

(2) For Tax Assistants :-

(i) Degree of a recognized University or equivalent, and

(ii) Having Data Entry Speed of 8,000 key depressions per hour.

04. SPORTS ELIGIBILITY :

Appointment can be made of a sportsman considered meritorious with reference to the following criteria.

Sportsman/Sportswoman who have represented

- (i) a State or the Country in a National or International Competition in any of the games/sports mentioned in the list as per No. 6 below.
- (ii) their University in the Inter-University Tournaments conducted by the Inter-University Sports Board in any of the games/sports mentioned in the list as per No. 6 below.
- (iii) the State Schools Team in the National Sports/Games for schools conducted by the All India School Games Federation in any of the games/sports mentioned in the list as per No. 6 below.
- (iv) sports persons who have been awarded National Awards in Physical Efficiency under the National Physical Efficiency Drive.

05. SELECTION OF THE CANDIDATES :

The applications will be scrutinized and suitable candidates will be short listed for further selection procedure. For selection, the short listed candidates are required to appear for following tests :-

(a) Ground/Proficiency Test, (b) Written Test, & (c) Interview

Success in the above test confers no right to appointment unless Department is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
