**Directorate of Income Tax (Systems)** invites bids from reputed, established and reliable Service Provider for the **establishment and running of Aayakar Sampark Kendra for Income-tax Department.**

**Details**

Bids are invited from an established BPO/Call Center Service Providers who would set up and operate **A National Call Center (in NCR) and four Regional Call Centers in Jammu (J&K), Jangipur (West Bengal) Kochi (Kerala) and Shillong (Meghalaya).**

The Scope of work\* for the Service Provider is to;

- Provide a toll free number facility for the callers.
- Identify the premises for the Call Centers and establish necessary infrastructure at the above mentioned locations so as to support **40 Seats at the National Call Center** and **10 Seats at the each of the Regional Call Centers** (A total of 160 TRAs supporting callers in two-shifts).
- Hire, train and manage a team of Taxpayer Relationship Agents (TRAs) who would be providing services to callers (taxpayers) such as answering PAN/TAN related queries, assisting taxpayers in the filing and submission of various return forms, handling of grievances etc.
- Establish a Call Center model which is scalable, centralized and interconnected.

The contract is for a period of 3 years extendable by 2 years.
