Sir/Madam,

I am directed to state that the some posts of Members in the Central Board of Direct Taxes in the Department of Revenue in the pay scale of Rs.24,050-650-26,000/- are likely to fall vacant in the next financial year ie., 2007-08. In terms of the Central Board of Direct Taxes (Chairman and Members) Recruitment Rules, 2006, these posts are to be filled on deputation /absorption basis. The said Rules are available on our website finmin.nic.in. The following categories of officers are eligible for appointment to these posts:

(I) Officers of the Central Government appointed on a regular basis in the Grade of Rs. 22,400-24,500/-

AND

(II) possessing the following essential qualifications :-

- (a) Having at least 15 years of experience in administering and running the direct tax administration in the Central Government with at least 10 years of experience in the field formations of Central Board of Direct Taxes;
- (b) Having high professional merit and excellence ; and
- (c) Having impeccable reputation of integrity

Note:

- (i) The normal eligibility conditions of maximum age of 56 years on the date of closing of applications shall not be applicable in cases of absorption.
- (ii) No person with less than 1 year residual service on the date of occurrence of vacancy for which selection is being made shall be eligible for consideration.

2. It is requested that applications fulfilling the eligibility criteria as specified above in this regard may be sent through the CBDT to this Department by **Friday, 15 December 2006** in the enclosed proforma (Part A &B).
