NOTICE INVITING QUOTATIONS

Sealed quotations are invited on behalf of the Principal Commissioner of Income Tax, VU - 1, Burdwan from experienced and resourceful bidders for installation of 49 (Forty Nine) balanced distributed internet connections from 07 (Seven) FTTH connections with necessary materials and equipments for installation in Aayakar Bhawan, Burdwan, Court Compound, Burdwan - 713101. The sealed quotations will be opened as per schedule given below in presence of the bidders, who may wish to remain present. The time of opening quotations may be changed subject to presence of members of Purchase committee. Relevant document can be obtained from the Joint Commissioner of Income Tax (VU) - 1(2)(1)[OSD], Burdwan on any working day.

NOTE: Technical Bid and financial Bid are to be submitted in two separate sealed envelopes and these two sealed envelopes are to be submitted together inside a bigger sealed envelope. "Violation of this will be treated as disqualified."	

TERMS & CONDITIONS:-

The bid consists of two parts, viz., (i) Technical Bid and (ii) Financial Bid. The terms and conditions of these parts are as under:

(i) Technical Bid: Bidders must submit the self-attested photocopies of the following documents:

1. Valid trade license.
2. PAN card.
3. Aadhar card/Partnership Deed/Memorandum of Association.
4. GST registration certificate, latest GST return, if any.
5. ESI certificate, PF certificate, if any.
6. Udyam Registration Certificate of Govt. Of India (MSME), if applicable.
7. Experience of similar services.
8. Undertaking for replacements/service/installation must be provided in case of any faults arisen within One Year from the date of completion of installation work.

Original certificates or documents as mentioned above must be produced on demand.


(ii) Financial Bid:

1. Bidders are to quote the costing of required materials and equipments (Cable, Router, Switch etc) as specified in "Table I" with installation charges separately with specification of quantity, brand, price rate, etc.
2. Bidders shall also compute item-wise the total costing of materials and equipments with installation charges including applicable taxes separately and quote the same in absolute numeric values, both in figures and words. Overwriting in the rate quoted in word or figure shall lead to cancellation of the bid.
3. Rate offered by a bidder in the quotation shall be treated as final and subsequent negotiation for change in price shall not be allowed.

General Terms & Conditions:

1. Unless the Technical Bid is fulfilled, the Financial Bid will not be considered at all.
2. In case of bid emanating from cartelization of bidders, entire tender process will be cancelled.


3. Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
4. No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any co-operative society / Government owned company / Government undertaking / corporation etc. In other words, all participating bidders will be treated on equal basis only and no favourable /special consideration will be accorded to any bidder.
5. Bidder must submit sealed envelope clearly mentioning the title of the work "Installation of 49 (Forty Nine) balanced distributed internet connections from 07 (Seven) FTTH connections" on top of the envelope.
6. TDS and applicable GST /Cess (if any) will be deducted as per existing rates of government.
7. Site visit may be done by the bidders at their own cost.
8. Successful Bidder will have to execute a formal agreement on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the "Principal Commissioner of Income Tax, VU - 1, Burdwan" wherein description, specification of work and other mandatory conditions and issues will be detailed. Failure to execute the contract will lead to automatic cancellation of the same.
9. The undersigned is not bound to accept the lowest bid and reserves the right to accept or reject any or all bids, as the case may be without assigning any reason whatsoever.
10. Any bid received from a bidder without authentication or correction made in rate quoted in word or figure shall lead to cancellation of the bid.
11. Application from bidders will be received without verification. The application of bidders will be verified after opening the quotations.
12. Both Technical & Financial Bid will be opened in the presence of all the members of Purchase Committee and the interested bidders at the time and date mentioned above.
