**Subject: Information for inviting sealed quotations for the printing and publication of two TPI Series Booklets – regarding –**

Sealed quotations are invited on behalf of the Addl. DG of Income-Tax (PR, P & P) for printing of **2500** copies each of the following TPI Series booklets :

- (1) Tax Treatment of Foreign Income of persons resident in India (TPI-16) (48 pages)
- (2) Valuation of Perquisites (TPI-36) (60 pages)

**Eligibility**

1. The tenderer should have the experience of providing similar works for at least 3 years in any of the Department/Autonomous Institutes/Universities/Public Sector Undertakings of the Government of India or Government of NCT of Delhi or any other State Government or Public Sector Banks or Local Bodies/Municipalities. Proof to this effect to be attached with Technical Bid.

2. The tenderer firm/agency/company should have valid registrations such as Permanent Account Number (PAN) of the Income Tax Department; GST Registration Number; Registration Number of the Agency/Firm etc.
3. The tenderer should submit an undertaking with the Technical Bid to the effect that he or his firm has not been blacklisted by any of the Departments/Organizations of the Government of India/Government of NCT of Delhi and no criminal case is pending against the said firm on the date of submission of this bid (Prescribed pro forma as per Annexure attached).
4. The tenderer should submit an undertaking with the Technical Bid to the effect that Terms and Conditions of the Tender are duly accepted/signed with the stamp of the prospective bidder.

**Procedure of submission of bids:**

The following documents should be placed/enclosed/attached with the Technical Bids:

1. Name of the organization, address, phone number, fax number, mobile number and e-mail ID of the responsible person.
2. Self attested copy of PAN Number card under Income Tax Act;
3. Self attested copy of GST Registration Number card under GST Act;
4. Self attested copy of Valid Registration Number of the Agency/Firm;
5. EMD (Bid security and performance security) of Rs. 5,000/- payable in form of Pay order / Bank Draft in favor of "ZAO, CBDT, New Delhi";
6. Prescribed Technical Bid tender form (as per Annexure – I);
7. An undertaking to the effect that the firm/agency has never been blacklisted by any of the Department / Autonomous Institutions/Universities/Public Sector Undertaking of the Government of India or Government of NCT of Delhi or any other State Government or Public Sector Banks or Local Bodies / Municipalities and no criminal case is pending against the said firm / agency (as per Annexure – III);
8. Proof to the effect that tenderer has experience of providing similar works for at least 3 years (as per Annexure – III);
9. Terms and conditions duly accepted/signed with the stamp of the prospective bidder (as per Annexure – III);
10. Self attested copies of P&L account & balance sheet for F.Y. 2014-15, 2015-16 & 2016-17 in support of turnover exceeding Rs. 50 lakhs in each of the years.
11. Copies of Income Tax Returns for A.Y. 2015-16, 2016-17 & 2017-18.
12. One Sample of the publication of work of similar nature printed, prepared by the party earlier.

**Opening of Technical Bid**

1. Technical Bid will be opened only of those firms whose EMD is received in original on or before schedule time of opening of Technical Bid as per tender Document.

**Opening of Financial Bid**

1. Financial Bids will be opened only of those firms which qualify in technical bid.

2. In case, any holiday is declared by the Government on the day of opening of the tender, the tender will be opened on the next working day at the same time but the tender box will be sealed on the scheduled day and time.

### **Awarding of Tender**

The tender will be awarded to the lowest bidder of the combined price quoted for booklet 1 and booklet 2.

### **Terms & conditions:**

1. Each quotation should be submitted in two separate sealed envelopes one titled "Quotation of Technical Specifications" containing duly filed, signed and stamped Annexure-I & Annexure-III and the other titled "Financial Quotation" containing duly filed, signed and stamped Annexure-II.
2. Earnest Money of the selected bidder shall be retained as security deposit till the successful completion of the job. If the selected bidder seeks to withdraw, his Earnest Money shall be forfeited.
3. Cost of preparation of Camera Ready Copy (CRC) for both the books shall be borne by successful bidder.
4. No advance payment shall be made for this work.
5. Before starting the final printing of the book, the selected bidder shall get sample copies approved from this office.
6. Sealed quotations in two envelopes (Technical & Financial) addressed to the Directorate of Income Tax (PR, P & P), 6<sup>th</sup> Floor, Mayur Bhawan, Cannaught Circus, New Delhi – 110001 and subscribed "Confidential/ Quotations for printing of publication **2500** copies each of TPI Series booklets must be dropped in the Tender Box placed in Room No. 604, 6<sup>th</sup> Floor, Mayur Bhawan, Cannaught Circus, New Delhi – 110001 latest by 11:00 A.M on 20.03.2018.
7. The Technical quotations shall be opened at 11:30 AM on 20.03.2018 and Financial quotations of the parties shortlisted on the basis of Technical quotations shall be opened at 12:30 PM on 20.03.2018 in 6<sup>th</sup> Floor, Mayur Bhawan, Cannaught Circus, New Delhi – 110001, in the presence of representatives of those bidders who may wish to be present.
8. The tenderer should take care that no column in the tender document should be left blank which would be otherwise making the tender liable for rejection.
9. Any act on the part of the tenderer to influence anybody in the Directorate is liable for rejection of the tender.
10. The prices quoted should be inclusive of all charges, transportation, packaging, delivery and taxes.
11. Each paper of the bid should be serially numbered and duly signed by the bidder with the seal of the firm on every page.

### **Cancellation of Tender**

The Bids will be rejected in the following event and no correspondence thereof shall be entertained, whatsoever:

1. Information sought being found false or detected incorrect or incomplete at any stage prescribed in tender.
2. Ineligibility or incompetency detected at any stage of the tender processing.
3. Failure to submit Technical and Financial Quotations in separate envelopes.

4. Failure to submit any document asked for in the clause "Procedure of submission of bids" mentioned above.
5. Failure to submit details in the prescribed format as per attached annexure.
6. Any conditional tender will not be entertained and is liable to be rejected.

**Penalty**

1. Penalty shall be imposed @ Rs.1000/- per day for delay in supplying the books on pro-rata basis.
2. If any defect found in the printed book, penalty @ 2% for minor defect and @5% for major defect will be deducted from the billed amount.

**Dispute**

This Directorate reserves the right to reject any or all the quotations without assigning any reason. Legal dispute, if any will be enforceable within the jurisdiction of the Delhi High Court. No communication in this regard shall be entertained.

**Forfeiture of Bid Security/Performance Security**

The Bid Security/Performance Security will be forfeited in the following conditions:

1. If at any stage, any of the information/declaration given by the bidder is found false.
2. If a bidder withdraws his bid during the period of bid validity specified in the terms & conditions of tender.
3. In case of any lapse/default in honouring of the terms and conditions at any stage after submitting the tender.
