The quotations received will be opened on the same day i.e. on 28-05-2018 at 04.00 P.M., at Room No. 817, 08th Floor, Aayakar Sadan, Bodhi Tower, 548/2B, Salisbury Park, Gultekdi, Pune - 411037 in the presence of the Bidders or their representatives who may likely to be present. The Pr. Director of Income Tax(Inv), Pune reserves the right to cancel or postpone or reject the tender/bids received without assigning any reasons.

4. Interested bidders may submit their bids, along with **Earnest Money Deposit (EMD) of Rs. 5,000/- (Rupees Five Thousand only) per vehicle, by way of Demand Draft (DD) drawn in favour of ZAO, CBDT, Pune, payable at Pune.**

5. The vehicles will be available for inspection between 03:00 PM to 04:30 PM from 21-05-2018 to 22-05-2018.

6. The auction will be governed by the following conditions:

- The successful bidder will be required to deposit the balance bid amount after deducting earnest money of Rs. 5,000/- not later than 04:00 P.M. on 01-06-2018 by way of DD drawn in favour of **ZAO,**

CBDT, Pune, payable at Pune, failing which, the amount deposited will be forfeited.

- b. Quotation received without demand draft towards earnest money will not be considered and shall be rejected.
- c. The delivery of the auctioned vehicles will be given only after the successful bidder submits documentary evidence on support of residential status (ration card / voter identity card in case of individual, and Registration Certificates in case of Firm, etc.)
- d. The sold vehicles shall have to be removed by the successful bidder(s) immediately at his own expense.
- e. **The auctioned vehicles will be disposed of on "as-is-where-is" basis** and no guarantee for its worthiness or quality will be given by this department.

- g. The successful bidder shall not be allowed to withdraw his bid, failing which his earnest money will be forfeited.
