Inspection of the premises may be made between 11th October to 13th October 2017 between 10:30 am to 05:00 p.m.



ELIGIBITLY CRITERIA
&
TERMS AND CONDITIONS

1. Copy of PAN card is to be attached with the technical bid.
2. Copy / Proof of GST no. is to be attached with the bid.
3. The Original Equipment Manufacturer (OEM)/ Authorized dealers of reputed companies are invited for bidding.
4. The OEM / Bidder should have at least 3 years experience in supply, installation, commissioning, maintance of Aadhar Enabled Bio-metric Attendance Tablets in Government organizations (Central / State / PSU).
5. The bidder must have a turnover of Rs. 50 lacs per annum in each of the last 3 financial years .
6. The bidder must have successfully completed at least 3 orders in Government organization (Central / State / PSU) for supply, maintenance, commissioning, maintenance of Aadhar Enabled Bio-metric Attendance Tablets. Completion certificates relating to same shall be enclosed with the bid documents.

7. The bidder should have a working service centre in Lucknow for the last 5 years.
8. The OEM should have a toll free service number so as to ensure timely redressal of any service issues. For the first month commencing from date of complete installation, an one site engineer/technician would be deployed during office hours to facilitate smooth functioning and to address any teething issues.
9. The rate approved in this tender shall be valid for the whole of the period of the contract and no upward revision will allowed during the period of contract.
10. The firm must not make any compromise on quality. In case it is found at some stage that the quality is inferior to that already approved, the contract is likely to be cancelled and suitable penalty imposed on the firm, as decided by the Principal Chief Commissioner of Income Tax, Lucknow or Commissioner of Income Tax (Admn & TPS), Lucknow, which can be extended to blacklisting of the firm also.
11. The earnest money of 5% of the bid value in the form of fixed deposit / bank guarantee from any commercial bank in acceptable form in favour of **"Zonal Account Officer, CBDT, Lucknow"**. To be submitted with the bid document.
12. The said earnest money deposit will not bear any interest at the earnest money of the unsuccessful bidder would be returned without any interest after finalization of the contract.
13. The earnest money deposit of the successful bidder will be kept as performance security deposit and is refundable after 6 months of successful commissioning of Aadhar Enabled Bio-metric Attendance Tablets in the premises.
14. In case the contractor fails to supply the requisite items in time or dishonor the contract in any way, the contract awarded shall be liable for outright cancellation/termination, without any reason thereof, and the security deposit and payment due to him, if any, shall also be forfeited.
15. No advance payment will be made under any circumstances.
16. The EMD will stand forfeited if the successful bidder withdraws on notifying the rates, refuse to accept the tender or violate any other terms and conditions of the tender.

17. The payment will be made through ECS on receipt of bills in triplicate and after delivery and installation of the items.
18. The bid should also include annual maintenance contract for 2 years excluding warranty period.
19. The Pr. Chief Commissioner of Income Tax, Lucknow or Commissioner of Income Tax (Admn. & TPS), Lucknow reserves the right to terminate the contract at any time without assigning any reasons thereof.
