Sub:- Fixing of dates of document verification of selected candidates through Sports recruitment conducted by the Income Tax Department, Mumbai for the post of Inspector of Income Tax, Tax Assistant and Multi Tasking Staff on the basis of result of Sports recruitment - 2012 in the Pr. Chief Commissioner, Mumbai - Reg

The list of candidates who have been selected for appointment on the basis of result of Sports recruitment - 2012 and in respect of whom dates for document verification have been fixed is enclosed herewith. The candidates are required to report to the Room No. 383, 3rd Floor Aayakar Bhavan, M.K. Road, Mumbai - 400020 on their respective dates at 11:00 am sharp and also to bring along with them, the following documents :-

- Attestation form (11 pages) completely filled up in duplicate (all in original with recent photograph) (format enclosed)
- Medical Statement and Declaration(2 pages) (format enclosed)
- Relevant Sports Certificates (Original and Xerox copy of all documents)(Self attested).
- Marks Sheet and Passing Certificate related to educational qualifications from Std.10th to last qualified Degree
- Proof of Age (School Leaving Certificate/Std. 10th Certificate showing the Date of Birth)
- Certificate of Physical Disability (if applicable to the candidate)
- Service Leaving Certificate/ Discharge book of Ex-Servicemen (if applicable to the candidate)
- If belonging to SC/ST/OBC category, valid caste certificate issued in the Central Government format by the competent authority in this regard (two copies).
- **All the above mentioned documents should be brought in original along with a self attested Xerox copy of each.**
- Evidence in support of claim of age relaxation, if any.
- If the candidate is a Central/State Government employee, he/she may produce this letter to his/her controlling authority to enable them to provide his/her medical examination report, along with police verification report, vigilance clearance, No objection certificate and character certificate (original / attested copy) obtained at the time of his/her appointment and bring all these documents through proper channel at the time of Document Verification .
- Fully filled Candidate's Details Form along with required enclosures (Copy of the format is enclosed).
- 5 recent photographs.

A copy of the Attestation Form (along with instructions to fill the same), Medical Statement and Declaration Form and Candidate's Detail Form is also being uploaded on the website www.incometaxindia.gov.in. Candidates are requested to download the forms, fill them up by hand as per instructions, and carry the same with them for document verification.

All the candidates are instructed to bring complete addresses of the respective District Police Headquarters where he/she has resided for more than one year in last five years (with pin code) and also the complete address of the respective office of the concerned authority from where their caste certificate has been issued (if applicable).
