A 3-day Course on "Dark Web and Cryptocurrency" is scheduled to be held at the Sardar Vallabhbhai Patel National Police Academy, Hyderabad, during 3<sup>rd</sup> to 5<sup>th</sup> July, 2024.

2. **The objective of the Course is to facilitate learning in:**

- Concepts of anonymity and privacy.
- Fundamentals of surface web, deep web, dark web and cryptocurrencies.
- Impact of dark web on crime landscape.
- Accessing dark web through various applications.
- Intelligence gathering from various sources on dark web.
- Documenting and monitoring dark web sites.
- Investigating dark web and related offences.

3. It is requested to nominate two eligible officers of the rank Addl. Superintendent of Police to Inspector General of Police from each State/UT/Organization, or the rank Joint Commissioner to Commissioner, Income Tax/Central GST/Customs from CBDT/CBIC, or the rank Joint Director to Special Director from ED, to attend the Course as per the format given below:



5. The Course is residential and the participants of the Course shall stay in the accommodation provided by the Academy. The expenditure to be incurred on boarding and lodging of the participants shall be met by the Academy. However, the expenditure on account of the travel of officers for attending the Course may be borne by the respective State/Central Government Department. It is informed that as per the SOP of the Academy, those officers against whom any criminal case, DE/PE etc. is in currency or contemplated are not eligible to undergo any training programme/course/seminar/workshop at the Academy. Hence, nominations of eligible officers may only be sent.

6. The dress order for the Course participants is Formal Civvies i.e. full sleeve shirt, trouser and tie for gentlemen and salwar kameez / saree / business suit for ladies.

7. The nominees may be advised to proceed for the Course only after receiving confirmation of acceptance of their nominations from the Academy. The officers nominated for the Course are required to report at the Academy by the evening of 02<sup>nd</sup> July, 2024 i.e. one day before the commencement of the Course. Transport from Hyderabad Airport / Railway Station to the Academy and back will be provided by the Academy as per travel plan provided by the participants.
